Lynnville City Council Meeting Minutes August 12, 2020 – 5:30 p.m. Lynnville City Hall

Guests: Josh DeWitt, Faye Brand, Mark Lagaveen and Alex Fennig joined the meeting at 6:00p.m.

MEETING AGENDA: Motion made by Newberg to approve the amended agenda, seconded by Van Maanen, all ayes motion carried.

MINUTES OF PRIOR MEETING: A motion was made by Carney and seconded by Newberg to approve the July13, 2020 meeting minutes.

NEW BUSINESS:

Resolution 081020: Newberg made motion to approve Resolution 081020 renewing Smokin J's Liquor License, seconded by Van Maanen, all ayes, motion carried.

Library Board: Mark Lagaveen, Library board liaison, presented the council with happenings at the library. Lagaveen stated that the humidity level is high at the library, there is a large bubble in the flooring that may be due to the humidity and pressure of books on the floor. To prevent damage to the books, a dehumidifier is being recommended to see if that will help resolve the issue and or if there is an underlying issue with the building itself. Newberg made motion to purchase a portable dehumidifier using money from the general fund, seconded by Arment, all ayes, motion carried. DeWitt will be in charge of emptying the humidifier. Books will continue to be Curbside pickup Only until the State mandates otherwise or when Newton Library opens to the public. Several light bulbs need replacing..DeWitt put it on his to do list. Board felt the need to hire a part time librarian to help cover if current staff need to be gone for family or personal issues. Sally Van Wyk has been hired. Arment made motion to spend up to \$500 extra budget dollars to help train Van Wyk, seconded by Van Maanen, all ayes, motion carried. Maanen made motion to pay Van Wyk \$8.00 an hour wage, seconded by Newberg, all ayes, motion carried.

Dust Control at Old Setts: Smokin J's is inquiring about dust control for Smoke on the Water. Cost will be \$400.00. Newberg made motion to pay ½ the cost if Smoke on the Water would pay the other ½. Going forward, dust control will be provided and rental rates at Old Setts may be adjusted, Seconded by Arment, all ayes, motion carried. **OLD BUSINESS**: Alex Fennig of Garden and Associates was present to answser council questions concerning the sewer work and added work that needs done. On East St, 2 of 3 lines checked had heavy flow indicating rain getting in after a heavy rain occurred. These lines were televised, no indication was given if lining these laterals would solve the issue. There was no direct connection as to the source of the heavy rain...Could be from upstream of water running in between joints. Options are 1: to install Vac-a-tee cleanouts and line 35' of sewer to each lateral for 21,900.00 + traffic control, or 2: Line 5' of sewer lateral to each address for 10,140.00 + traffic control of 3^{rd} option is to leave as is. Newberg made motion to take no action at this time if either option is not guaranteed to work, seconded by Carney, all ayes, motion carried. No need to spend more money if no guarantee it will work. All council agreed.

Council tabled the problem area at the Ball Park till later date.

MAINTENANCE REPORT: DeWitt stated has been busy with sewer pumps, mowing and weed eating.

Mayor James stated Monty Lukehart and Alvin Rozendaal removed 3 trees from Old Setts. Mayor James thanked them for their work, labor and equipment. Eric Lanser will be repairing a bad road spot by Peter and Kyra Smith's residence.
