**MEETING AGENDA:** Agenda was amended to add a date for the Max Levy Public Hearing. A motion was made by Newberg, seconded by Lageveen to approve the amended meeting agenda. All ayes, Motion carried.

**OLD BUSINESS**: Bids for electrical work for the generator was tabled until next month. Lageveen made motion to increate all part time library workers wages by \$2.00, seconded by Newberg, all ayes, motion carried.

Mayor James made mention that many stop signs in town are in bad shape. Will get quotes to replace them. He contacted Brandon Talsma again regarding compensating the city for the sand and time spend clearing Lynnville Hill and also stated has had many inquiries about any vacant lots in Lynnville for people to build a new house on.

**NEW BUSINESS:** The first reading of the Amended Title VI, Chapter 1-Water Service Article 3, Water Rate Ordinance was read. Rates will increase by 4%.. 0 to 2000 gal will increase to \$19.69, gallons over 2000 will increase to \$.60 per gallon. Newberg made motion to waive the 2<sup>nd</sup> and 3<sup>rd</sup> readings, seconded by Van Maanen. All ayes, motion carried. Rates will go into effect February 1, 2023.
