Lynnville City Council Meeting Minutes

July 14, 2025 – 5:30 p.m. Lynnville City Hall

MEETING AGENDA: Agenda was amended to 1st Street residents. A motion was made by Comegys, seconded by Van Maanen to approve the amended meeting agenda. All ayes, Motion carried.

MINUTES OF PRIOR MEETING: A motion was made by Comegys and seconded by Fraker to approve the June meeting minutes. All ayes, Motion carried.

PUBLIC INPUT: Many **r**esidents of 1st Street voiced concerns about finding a solution to having water in their basements which seems to be occurring more often after each rainfall. Granted no one can control the weather or the amount of rain. The previous sewer lining project did not alleviate this problem. Residents stated that after an overflow was capped by the DNR, water seems to be backing up more often. During the storm, manholes were checked and it was determined that the south end of town showed more significant flow than any other part of town. Extra pumps were brought in by Jasper County EMA. Should the whole system be cameraed again, conduct another smoke test, consult with another engineering firm for a second opinion, are gutters or sump pumps connected to the sewer system, is the storm sewer somehow connected to the sewer system, were all questions that the council discussed. A dye test will be conducted to help determine if storm water is entering the sewer system. Residents also mentioned all tree debris that has been hauled into the dump. Mayor will speak to the party responsible for bringing in all the debris and root balls.

OLD BUSINESS: Clerk Arthur reported that pictures and quotes to repair the damage done to the tennis court area has been submitted to the insurance company of the party responsible.

NEW BUSINESS: Resolution 71425 Disposing of Old Records: Comegys made motion to approve resolution 71425, seconded by Fraker, all ayes, motion carried.

Election Seats: Clerk reported that the mayor and 3 council seats will be up for re-election. If anyone is interested in running, please contact city clerk for the paperwork.

Water Tower: Council feels that water tower issues were caused by exposed outside wires that eroded over time, causing a blown breaker which in turn shut the pump off. The equipment, controls & gauges are old and becoming outdated. Maintenance and repairs need to be done along with a better way to communicate when the city is experiencing problems. N. Arthur stated that Jetco was consulted and will be submitting a bid for repairs/updates to the system.

Building Permit: Fraker made motion to approve a 56 x 64 building permit submitted by Eric Lanser, seconded by Van Maanen, all ayes, Motion Carried.

MAINTENACE: N. Arthur reported sewer & water in compliance. Truck will need new tires before winter and the tractor has an oil leak. Council consented to getting both items taken care of. City Dump discussion took place: how to control who brings in waste, put a fence around it with certain hours only or close it, where topics discussed. No action taken on city dump.

PUBLIC INPUT: None.
