## **Lynnville City Council Meeting Minutes**

## September 8, 2025 – 5:30 p.m. Lynnville City Hall

Mayor Mark Newberg was present.

**MEETING AGENDA:** A motion was made by Tompkins, seconded by Needham to approve the amended meeting agenda. All ayes, Motion carried.

**MINUTES OF PRIOR MEETING:** A motion was made by Tompkins and seconded by Fraker to approve the August meeting minutes. All ayes, Motion carried.

**OLD BUSINESS**: Mayor Newberg gave update on FEMA. The difference in pricing quotes caused by a mathematical error from the engineers caused the grant project to about be lost. Predisaster can not cost more than mitigation. State, Jasper Co EMA and city officials met and redevised the predisaster and mitigation numbers. If mitigation is approved, city will look into the adding more line to the lagoon which might alleviate some issues which occur during heavy rainfall.

**NEW BUSINESS:** GARRET DEHOEDT requested council approval to move the city's electrical meter for the lift station located on the business property due to more semi traffic. Weight of the semis on the lift station was one concern of the council. Council requested Dehoedt to present the cost associated with moving the meter to the council. No action taken.

**RAHN SAVAGE:** Savage stated that he wanted to discuss redoing the line to the lagoon, but Mayor Newberg had answered his question while discussing the FEMA update.

**TRICK OR TREAT NIGHT:** Trick or Treat Night will be help on Saturday October 25<sup>th</sup> from 5 p.m. to 7 p.m. The Lynnville Fireman's supper will be held on the same evening.

**ELECTION SEATS:** Any interested person desiring to be placed on the ballot for mayor or 3 available council seats will need to have their paperwork submitted to the City Clerk by 5:00 p.m. Thursday, September 18.

**BUILDING PERMIT:** Tompkins made a motion to approve a house building permit for Levi and April Laverman, seconded by Fraker, all ayes, Motion Carried.

**RESOLUTION 90825:** Tompkins made motion to approve Resolution 90825, Urban Renewal Report of \$0, seconded by Fraker, all ayes, Motion Carried.

**MAINTENACE:** N. Arthur reported sewer & water in compliance. Discharge will be started at end of October. Waiting on a bid from JETCO for new water tower panels and a bid from HydroClean to camera the ball park area to Cross Street. Have dye tested every storm sewer and nothing has showed in the main. Will be conducting more smoke testing in the ball field area later this month with Iowa Rural Water.

2 bids were received to remove 2 dead oak trees at the Cemetery: Brad Rozendaal \$350 per tree, Jake McElroy \$250 per tree. Tompkins made motion to accept McElroy's bid, seconded by Needham. All ayes, motion carried. Arthur is requesting price quotes from area dealerships for a new truck and snow equipment. To date one quote has been received just under \$68000, waiting for a few more quotes.

Mayor Newberg stated that himself along with Cat Terlouw will be meeting at Old Setts to discuss the possibility of starting a community garden out there.
